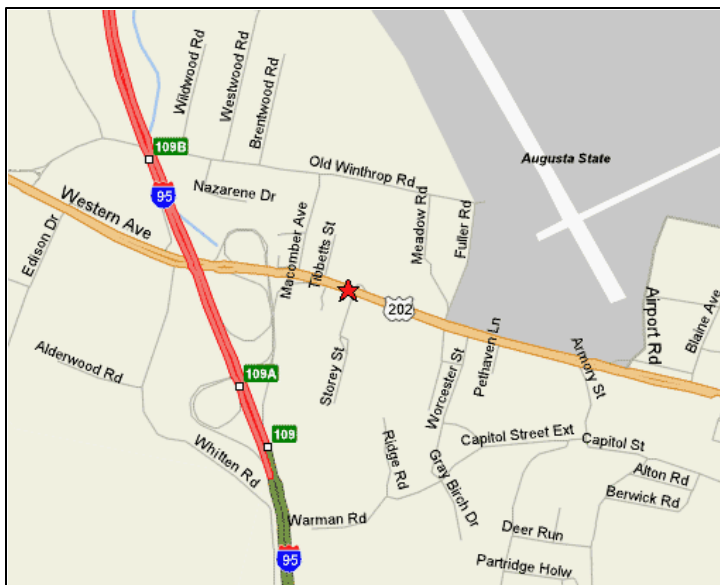
Lodging

From the south: Take I-95 North. In South Portland, take Exit 6A for I-295 North. Follow I-295 through Portland until it once again becomes I-95, just past Falmouth. Continue North for approximately 50 miles. After the Gardiner toll booth, go 7 miles to **Exit 109** in Augusta. Bear right off the exit onto Western Avenue. The Senator Inn is immediately on your right.

From the north: Take I-95 south to **Exit 109A**. Bear right off the exit onto Western Avenue. The Senator Inn will be immediately on your right.
